## **RFQ 146/2016/17: Appointment of Health and Safety Agent for Knysna Municipality**

The Construction Regulations 5 (*Duties of the client, Knysna municipality therefore the agent should perform these duties on the municipality's behalf*):

### **Background**

Knysna Municipality plan to do the following projects:

The contract period for these projects will be 12 months.

The responsibility of the health and safety consultants will be:

- 1)(a) - prepare a baseline risk assessment
- 5(1)(b) - prepare a coherent site specific health and safety specification
- 5(1)(c) - provide the health and safety specs to the designer
- 5(1)(d) - ensure that the designer takes the health and safety specs in consideration during the design stage
- 5(1)(e) - ensure that the designer carries out all responsibilities contemplated in regulation 6
- 5(1)(f) - ensure that the health and safety specs are included in the tender documents
- 5(1)(g) - ensure that potential principal contractors submitting tenders have made adequate provision for the cost of health and safety measures
- 5(1)(h) - ensure that the principal contractor to be appointed has the necessary competencies and resources to carry out the construction work safely
- 5(1)(i) - ensure co-operation between contractors appointed by the client to enable each of those contractors to comply with the Construction Regulations 2014
- 5(1)(j) - ensure before any work commences on a site that every principal contractor is registered and in good standing with the compensation fund or with a licensed compensation commissioner (*refer also to regulation 5(3); when a fatality or permanent disability occurs on a construction site, ensure that the contractor reports the incident to the provincial director in accordance with section 24 of the OHS act & regulation 8 & 9 of the General Administrative Regulations, 2013 and also that the report includes measures that the contractor intends to implement to ensure a safe construction site*)
- 5(1)(k) - ensure that the municipality has appointed every principal contractor in writing for the project or part thereof on the construction site
- 5(1)(l) - discuss and negotiate with the principal contractor the contents of the principal contractor's health and safety plan and must thereafter finally approve the plan for implementation
- 5(1)(m) - ensure that a copy of the principal contractor's health and safety plan is available on site
- 5(1)(n) - ensure that each contractor's health and safety plan is implemented and maintained
- 5(1)(o) - ensure that periodic health and safety audits and document verification are conducted at least once every 30 days

- 5(1)(p) - ensure that a copy of the health and safety audit report is provided to the principal contractor within 7 days after the audit
- 5(1)(q) - stop any contractor from executing a construction activity which poses a threat to the health and safety of persons which is not in accordance with the municipality's health and safety specs and the principal contractor's health and safety plan for the site.
- 5(1)(r) - where changes are brought about to the design or construction work, make sufficient health and safety information available to the principal contractor to execute the work safely
- 5(1)(s) - ensure that the health and safety file is kept and maintained by the principal contractor

**Construction Regulations 7:** an agent must manage the health and safety on a construction project for the municipality and be registered with a statutory body approved by the Chief Inspector as qualified to perform the required functions.

**Service providers must submit a comprehensive CV and motivation. Interested service providers must enclose a valid tax clearance certificate, BBBEE Certificate as well as a current Municipal Rates Account.**

### **EVALUATION**

All bids will be evaluated by a panel on basis of functionality (100%) and Price 80. The points scored for functionality will not be carried over to price, but will only be used as a gate keeping exercise. The final evaluation will be done in terms of the Council's Preferential Procurement Policy which states 80 for price and the remaining 20 for B-BBEE.

Adjudication:

The proposals will be adjudicated in terms of Council's Supply Chain Management Policy.

With regard to functionality the following criteria will be applicable:

### 1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to all bids:
- the 80/20 system for requirements with a Rand value of up to R1 000 000 (all applicable taxes included); and
  - the 90/10 system for requirements with a Rand value above R1 000 000 (all applicable taxes included).
- 1.2 The value of this bid is estimated not to exceed R200 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.
- 1.3 Preference points for this bid shall be awarded for:
- (a) Price; and
  - (b) B-BBEE Status Level of Contribution.
- 1.3.1 The maximum points for this bid are allocated as follows:

- 1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- 1.5 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.
- ### 2. DEFINITIONS
- 2.1 “**all applicable taxes**” includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2 “**B-BBEE**” means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3 “**B-BBEE status level of contributor**” means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 “**bid**” means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 “**comparative price**” means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 “**consortium or joint venture**” means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;

- 2.8 “**contract**” means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 “**EME**” means any enterprise with an annual total revenue of R5 million or less
- 2.10 “**Firm price**” means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 “**functionality**” means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 “**non-firm prices**” means all prices other than “firm” prices;
- 2.13 “**person**” includes a juristic person;
- 2.14 “**rand value**” means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 “**total revenue**” bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.16 “**trust**” means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.17 “**trustee**” means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

### 3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

### 4. POINTS AWARDED FOR PRICE

#### 4.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$P_s = 80 \left( 1 - \frac{P_t - P_{\min}}{P_{\min}} \right) \quad \text{or} \quad P_s = 90 \left( 1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

- $P_s$  = Points scored for comparative price of bid under consideration  
 $P_t$  = Comparative price of bid under consideration  
 $P_{\min}$  = Comparative price of lowest acceptable bid

### 5. Points awarded for B-BBEE Status Level of Contribution

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.

5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.

5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
