Walls:

- Scouring and preparation of surfaces
- Smooth out nail pops, cracks and holes with good quality filler.
- Carve out and fill joint cracks
- Painting with medium gloss white paint (where walls are painted) or appropriate wood finish oil or vanish.

Floor boards:

- Remove cracked, split or damaged boards
- Remove infested, damp and rotten boards
- Replace loose and creaking boards
- Fill gaps between floorboards
- Insert new battens and joists for support where necessary
- Apply two coats of wood finish oil or vanish where appropriate
