- Cutting of all identified trees.
- Damage to road surfaces, fencing and other infrastructure must be prevented. Contractor will be held liable for any such damages.
- All cut logs and other debris must be taken to an approved dump site.

REQUIREMENTS

- A qualified Health and Safety representative and First Aider (**with relevant and up-to-date documentation, attached certificates**) must be on site for the duration of the project.
- The chainsaw operator(s) must be qualified with training documentation and/or contactable references. (**This must be attached with document**)
- Appropriate tree felling equipment and road signage must be used on site.
- All staff on site must wear full PPE at all time
- Trees with diameter larger than 15cm to be cut into maximum 1m length and removed from site.
- Contractors must have **Valid Insurance for Tree Cutting** not less than R1 000 000 - 00, **proof of such insurance must be attached with document.**
- **Good Standing Letter from Insurance Company** must also be submitted with document
- Contractors must have **Letter of Good Standing with Workman's Compensation Fund**, submit with document.
