### **SPECIFICATIONS**

#### **OPTION 1: Blombos Reservoir as per existing layout of 38m**

#### **FENCING CONTRACT: 2,05m High Nylofor Medium System Charcoal (Anthracite) and single Leaf Gate Specifications**

The quotation - for the supply and erection of fencing as indicated, the specifications as follows:

- Posts** : 2,6m x 70mm x 44mm Bekafix Secure Posts  
The panels are fixed laterally onto the posts and secured with anti-vandal metal security fixators. The H-shape welded tubing posts are galvanised and PVC coated and supplied complete with a polyamide cap and accessories
- Panels** : 2,05m High Nylofor Medium Panels. The panels have a width of 2,5m and a height of 2,05m. Apertures: 100mm x 50mm (H x W).  
Core Wire diameter: 3,60mm, PVC Coated wire diameter 3,95mm.
- Coating Techniques** : Panels made out of galvanised wires. A pre-treatment process guarantees a perfect PVC-coating adhesion to the product surface. The posts are in and outside galvanised (min. coating 275g/m<sup>2</sup>, both sides together), in accordance with SANS 10224-2. Afterwards an adhesion coating is applied and finally the posts are plastic coated (min. 60 micron)
- Gate Posts** : 2 x 2,6m x 100mm x 100mm x 3mm Galvanised and powder coated or painted
- Gate** : 1 x 1.5m x 2,05m Double Leaf Gate to match the fence  
Gate frame to be made from 50mm x 2mm Square Tubing, outer frame for each leaf and on vertical for each leaf, including 3 x 30mm x 5mm cover plates per leaf with 100mm x 30mm bullet hinges. The gate will have one drop bolt and sliding bolt that can be locked with a padlock.

All poles are spaced at  $\pm 2,5$ m centers and planted in 15mpa concrete.  
Please note the gate posts and gate can be powder coated or painted
