6. No fires to be made on site.
7. All waste material to be removed from site and transported to the Knysna Municipality green waste site adjacent to Old Place, Knysna or chipped on site and spread out to avoid the accumulations of heaps of combustible waste.
8. The work will be inspected by a senior fire fighter on completion.
9. Applicants must be able to identify the difference between alien and indigenous plant species.
