<b>A: Perimeter fence</b>		
<b>Mesh:</b> Enclose perimeter with galvanized welded mesh 1800 x 50 x 50 x 2.0mm		
<b>Poles:</b> Use CCA Treated pine poles 2.4m x 100mm with 600mm embedded underground @ 2 meters' apart.		
<b>Horizontal wire:</b> insert 4 horizontal rows of galvanized 4mm wire		
<b>Stapling:</b> secure fence to the poles using 25mm staples		
<b>Razor wire:</b> Attach razor wire on the top and bottom of the fence.		
<b>B: Gates</b>		
<b>1. Vehicle gate: 3m x 18m</b>		
<b>Frame:</b> Build a frame of 3m x 1.8m using rectangular steel tubes 76 x38mm. Insert crossing vertical & horizontal support using square tubes 38 x38mm.		
<b><u>Openings/gaps:</u></b>		
Use galvanized welded mesh(50x50x2.0m) to close the openings. The welded mesh must be welded onto angle bars.		
<b><u>Sliding:</u></b> Use 30x30x5mm angle iron for the track with a 6m x 10mm rod attached securely on top for easy sliding.		
Attach back guide angle 40x40x5mm to the gate for ease of sliding		
Insert 10mm y angle rods every 500mm into 300mm concrete to secure the track		
Attach 80 inch wheels to the frame per standard procedure		
Attach razor wire on top of the gate		
<b>2. Pedestrian gate</b>		
Erect a 1.8m x 1m pedestrian gate using rectangular steel tubes (76 x 38 mm). Insert crossing vertical & horizontal support using square tubes 38 x38mm.		
<b>Poles:</b> CCA Treated pine poles 2.4m x 100mm with 600mm embedded underground @ 2 meters' apart.		
The hinge pole must be supported by brace posts and wires attached horizontally to a wire post.
