- The RFQ is for the backfill and reinstatement of trenches and other excavations in existing roads and other paved areas.
- The rates submitted by Contractors is rate-only, and should be valid until 30 June 2021.
- Knysna Municipality will issue order to successful Contractor, which will be serving as the binding documents between the two parties.
- Knysna Municipality representative will instruct Contractor of areas to be repaired.
- Contractor must be able to supply proof of any additional materials not specified in BOQ purchased claimed under Section 6.
- Knysna Municipality have the right to enquire about approved dumpsite specified by Contractor.
- Knysna Municipality representative will complete check sheet and will do final sign-off.
- Knysna Municipality representative will approve sections of the work after visual inspection.
- A defect liability period of six (6) month after completion of works will be ensued.
- Should reinstatement/repairs sag within the defect liability period, the Contractor will be responsible to repair on own expense.
- **Only one (1) will be appointed.**
- **ONLY bidders that are in good standing with the Compensation for Occupational Injuries and Disease Act (COIDA) will be considered. The bidders should please attach letter of good standing with COIDA**

SCOPE OF WORKS

Method statement:

1. The Contractor must plan the work so as to minimise any Public / Traffic disruption.
2. Park all construction vehicle(s) in a safe and appropriate place as to minimize Public/Traffic disruption.
3. Place adequate road signage, construction boards, flagmen where needed.
4. All workers must wear the appropriate PPE (Personal Protective Equipment); flagmen must be present where necessary.
5. Neatly pick (or Saw-cut-depending on the size) the affected area, in a square (or rectangle) shape.
6. The section removed must be slightly larger than the actual excavated area, maximum 40 – 50mm border around excavated edges (No unnecessary enlarging the remedial area for additional payment purposes).
7. Remove unsuitable material until the sand level.
8. Unsuitable material, rubble and any other material (irrespective of its origin) must be removed from site and transported to an approved dumpsite.
9. Under no circumstances may unsuitable material, rubble and any other material be left on site or dumped on neighbouring properties, open areas, or pavements.
10. Ad-hoc dumping on any part of the site is strictly prohibited.
11. Selected fill blanket to be compacted in layers (not exceeding 300mm thickness).
12. The contractor should use the blasted G5/G7.
13. Sweep and clean the final G5 area until all loose material / debris is removed and surface is neat and tidy.
14. Tack coat inside, including the sides and top edges/ overspill.
15. Fill with cold mix / hot mix asphalt, min 20 – 30mm thick, approximate 5 – 10mm above road surface.
16. Compact the loose mix with a pedestrian roller until sufficient compaction is obtained. Just make sure the pedestrian roller used has a water tank on functional.
17. Final surface must be level with surrounding road level – no heaving or sagging.
18. Clean entire remedial area – road, sidewalk, SW channels – from any construction debris/rubble.
19. The Contractor is responsible for protection of the excavation until such time as the reinstatement is completed.

1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to all bids:
- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
 - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).
- 1.2 The value of this bid is estimated not to exceed R200 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.
- 1.3 Preference points for this bid shall be awarded for:
- (a) Price; and
 - (b) B-BBEE Status Level of Contribution.
- 1.3.1 The maximum points for this bid are allocated as follows:

- 1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- 1.5. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.
- #### 2. DEFINITIONS
- 2.1 **"all applicable taxes"** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2 **"B-BBEE"** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3 **"B-BBEE status level of contributor"** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 **"bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **"comparative price"** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **"consortium or joint venture"** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **"contract"** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **"EME"** means any enterprise with an annual total revenue of R5 million or less

- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **“non-firm prices”** means all prices other than “firm” prices;
- 2.13 **“person”** includes a juristic person;
- 2.14 **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.16 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.17 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:
