3 SCHEDULE OF DEVIATIONS

Notes:

5. Subject payment certificate for a duration of 10 months until
Details R517 920,70 is fully paid; and
- The sum deducted will be refunded to the contractor upon signing of practical completion certificate by engineer and client.
