AMENDMENT OF CONTRACTS PROCURED THROUGH THE SUPPLY CHAIN MANAGEMENT POLICY OF KNYSNA MUNICIPALITY

PURPOSE

To make public the intention to amend contracts procured through the supply chain management policy of Knysna Municipality.

LEGISLATION

In terms of the Municipal Finance Management Act No 56 of 2003 section 116 (3):

"A contract or agreement procured through the supply chain management policy of the municipality may be amended by the parties, but only after -

- (a) the reasons for the proposed amendment have been tabled in council of the municipality; and
- (b) the local community -
 - (i) has been given reasonable notice of the intention to amend the contract or agreement; and
 - (ii) has been invited to submit representations to the municipality".

PROPOSED AMENDMENTS

- (a) Expansion of Tender: T01 of 2018/19: Electrification of various areas from 2018/2019 to 2020/2021 in Knysna - to allow for additional time due to material backlogs as a result of the Covid-19 pandemic. Further details may be obtained from J Lawrence on jlawrence@knysna.gov.za.
- (b) Expansion of Tender: T63 of 2017/18: Electrification of informal areas in Knysna Municipality area of supply - to allow for additional expenditure of 20% and the extension of the contract period due to material backlogs as a result of the Covid-19 pandemic. Further details may be obtained from J Lawrence on jlawrence@knysna.gov.za.
- (c) Expansion of Tender: T52 of 2017/18: To perform electrical and associated works for a period of three (3) years - to allow for the extension of the contract period due to material backlogs as a result of the Covid-19 pandemic. Further details may be obtained from J Lawrence on jlawrence@knysna.gov.za.
