AMENDMENT OF CONTRACTS PROCURED THROUGH THE SUPPLY CHAIN MANAGEMENT POLICY OF KNYSNA MUNICIPALITY

PURPOSE

To make public the intention to amend contracts procured through the supply chain management policy of Knysna Municipality.

LEGISLATION

In terms of the Municipal Finance Management Act No 56 of 2003 section 116 (3):

"A contract or agreement procured through the supply chain management policy of the municipality may be amended by the parties, but only after -

- (a) the reasons for the proposed amendment have been tabled in council of the municipality; and
- (b) the local community -
 - (i) has been given reasonable notice of the intention to amend the contract or agreement; and
 - (ii) has been invited to submit representations to the municipality".

PROPOSED AMENDMENTS

- (a) Expansion of tender: T31 of 2018/19: Construction of a Multi-purpose centre, White Location, Knysna - to allow for additional expenditure due to standing time as a result of community interference and unrest on site. The expansion will be to the amount of R3,547,624.99 VAT included. Further details may be obtained from S Langlands on slanglands@knysna.gov.za
