REPORT FROM THE DIRECTOR: CORPORATE SERVICES

BACKGROUND & PURPOSE OF THE REPORT

In terms of Sec 49(2) of the Constitution, Act 108/1996 read with Sec 17 of the Electoral Act, Act 73/1998 the President of South-Africa, His Excellency Matamela Cyril Ramaphosa proclaimed **29 May 2024** as the day on which all registered and eligible voters will cast their votes in the General National- and Provincial Elections. The day was also declared a public holiday in terms of the Public Holidays Act, Act 36/1994. Most, not all, Municipal Councillors are in some form or another affiliated to Registered Political Parties participating in the upcoming general elections and would relish the opportunity to promote our Constitutional Democracy by actively preparing, canvassing and participating in the General National- and Provincial Elections.

In view of the above, it is hereby proposed that Council goes into recess from _____ to _____. Furthermore, it is proposed that Powers and Functions of Council be delegated to the Executive Mayor, except those functions which may not be delegated in terms of Section 160(2) of the Constitution, Act 108/1996 and/or any other legislation, for the recess period.

RECOMMENDATION OF THE MUNICIPAL MANAGER

- [a] That the Municipal Council stands prorogued for the period _____ until _____;
- [b] That, in view of the aforementioned period of recess, the Executive Mayor and the Municipal Manager be delegated to jointly perform all official Council duties, responsibilities and functions during the period of _____ 2024 to _____ 2024 with the exception of those indicated in Section 160(2) of the Constitution of the Republic of South Africa, 1996 viz:
- [i] the passing of by-laws;*
 - [ii] approval of budgets;*
 - [iii] the imposition of rates and other taxes, levies and duties;*
 - [iv] the raising of loans;*
 - as well as:*
 - [v] disposal of council properties;*
 - [vi] approval of Integrated Development Plan; and*
 - [vii] the appointment of Section 56 employees;*
 - [viii] Any other powers reserved exclusively for the Municipal Council;*
- [c] That the Executive Mayor report back at the Ordinary Council Meeting to be held in May 2024 regarding any decisions made during the recess period as mentioned in [a] above.
