## RFQ:

### SCOPE OF WORKS:

1. The roof, gutters including box gutter and channels must be swept and all foreign objects removed twice per month (first and last week of month OR as directed by the Senior Librarian).
  2. The service provider must attend to all flowerbeds every two weeks because of night soil falling from roof and trees in the property as well as those around the library in Memorial Square.
  3. The service provider must remove all litter and human excrement two times a week. E.g. Cans, bottles, plastic bags and faeces/human excrement in the courtyard and around the library premises.
  4. The forecourt and backyard must be swept and night soil removed from the yard and flowerbeds.
  5. The drains must be cleared of night soil and leaves falling into the drains, two times per week, preferably on a Monday and Friday OR as directed by the Senior Librarian.
  6. Trimming of the hedges at the entrance to the library and tree branches inside and adjacent to the library premises as needed.
  7. The service provider must remove all refuse collected, night soil, and litter immediately from the property.
  8. The windows must be cleaned once a quarter.
  9. All equipment and transport must be provided by the service provider.
  10. Work will be inspected on a weekly basis.
  11. Courtyards must be swept and weeded.
  12. The service provider must tend to all flower beds every two weeks which includes all beds on both properties as well as those adjacent to the streets in Queen Street and Main Road.
