### **Surge Generator (Thumper) 30kV LP30-2**

- The LP30-2 cable fault location system is the first system in the world that uses innovative remote location technology to locate power cable faults. It is mainly suitable for the accurate search of various main insulation faults of 0-35kV power cables.
- Under the control of the remote service center, it can break through geographical restrictions and locate fault points remotely and in real time.
- Fault location is more convenient, faster, safer and more effective. Its unique intelligent route difference fixed-point technology and cable path indication technology make the fault point determination faster and more accurate.

## **TECHNICAL SPECIFICATION: Surge Generator (Thumper) 30kV LP30-2**

**Scope of this specification cover the supply and training of a Shock discharge Generator.**

The shock discharge generator is used for the location of cable faults, by generating flashovers or punctures at the weak point of the cable insulation. For this purpose, the four impulse capacitors are charged and then discharged into the faulty cable via an operating spark gap. The equipment should be suitable for testing, pre-locating, and pinpointing conductor and insulation faults of low and high resistance, intermittent or flashing nature in PVC, PILC and XLPE H.T. underground power cables.

The Shock discharge Generator shall operate on 110 to 230 V, 50/60 Hz $\pm$ 5%, and single phase supply with standalone operation.

The system shall consist of the following:

1. Continuously variable shock discharge generator in steps of 0-30kV @ 900Ws.

2. Training on safety & use of the equipment
3. Back up service

**1. Continuously variable Shock discharge generator:**

The shock discharge generator shall be capable of providing repetitive surges at voltage variable from zero to the voltages mentioned below with output of minimum of 900Ws. It shall be possible to use the surge for breaking down the fault for analysis in conjunction with Time Domain Reflectometer (TDR) using the Impulse Current Mode (ICE) connected direct to the surge and Arm Reflection Mode (ARM) connected through a filter. It shall be possible to apply repetitive surge for pin-pointing the faults with the help of a pin pointing set. (TDR unit is separate unit that can be added to the Surge Generator to enhance the fault finding process.)

The shock discharge generator is a completely self-contained instrument and can be operated without any additional units. The four main sub-assemblies viz control unit, high voltage generator, impulse capacitors and the operating spark gap are mounted in a rugged pelican housing.

A built-in kV meter indicates the surge voltage and measures the high voltage directly at the capacitor bank internally. No External Capacitors will be acceptable from a safety aspect.

The connection of the instrument on the high voltage side to the faulty cable is made by means of a 4 m high voltage lead with a high voltage plug connector.

**The Technical requirements are:**

- a. Pre-Location Methods ARM, ICE
- b. Current output 30mA
- c. Output Voltage Range: (0-30kV) continuously adjustable @ 900Ws
- d. High Voltage Capacitors should be Steel case type with porcelain bushings build-in and not external from the unit.
- e. High Voltage Contactor should be Ceramic shield with tungsten tipped contacts
- f. Soft Discharge should be via two separate contactor discharge circuits for internal capacitors and cable capacitance
- g. Discharge devices shall be part of the systems internals.
- h. Meter : 0 - 30 kV (direct measurement)
- i. Weight of the unit should not exceed the max weight of 34kg

- j. The Dimensions of the unit should be (LxHxB) : 500 x 300 x 400
- k. Compatible to SPC20 Arc Stabilization Filter
- l. Standard accessories : a) Power cable NK-G 01
  - b) Earthing cable EK 01
  - c) 4 m high voltage cable HSK 13
  - d) Operating manual

## 2. Training

Handover training on the equipment shall be included. The training course offered shall include the following:

- a. The proper connection of the shock discharge generator
- b. The operation of the test units.
- c. The use of the software (where applicable)
- d. The interpretation of the results (where applicable).

## 3. Back Up Service
